Health Warranty: The warranty period for this puppy is for 1 year from the date of birth. The puppy must be kept in good physical condition. Buyer will, within 5 days of delivery, have a licensed veterinarian of their choice conduct a health examination at buyers expense. If a serious health issue is determined at that examination, the buyer may elect to return the dog to the seller at the buyer's expense and the seller will agree to provide a replacement dog of equal value when first available. Delivery of any replacement dog shall be at the buyer's expense.

This warranty covers fatal and life-threatening congenital disease. This includes kidney, heart, pancreas, and liver problems of a severe life threatening or life altering nature. In the unlikely event that a problem of severe life-threatening nature does occur within the warranty period, the seller will replace the puppy with a puppy of the same gender. The buyer will be responsible for having a written report of the problem of said puppy from 2 different licensed veterinarians.

The seller does not assume responsibility for any medical expenses incurred associated with any health problem or routine maintenance.

In the event that the buyer does not have the "within 5 days of delivery of health examination" conducted at their expense and, a correct and legible copy of documentation of that examination returned to the seller within 5 days of examination the guarantee and warranty will be null and void.

Health Conditions:

This

warranty does not apply to afflictions that are considered to be common to the French Bulldog breed. These include but not limited to cherry eye, entropic, "loose hips or knees", skin allergies, elongated soft palate, collapsed nostrils, uneven bites, allergies, or respiratory infections.

The health warranty does not cover the following treatable conditions. Intestinal parasites, coccidiosis, giardia, tapeworms, roundworms, hookworms, or whipworms. Also, does not cover fungal, bacterial skin mites, mange, (sarcoptic, cheyletiella, demodectic) conditions.

The BUYER is responsible for the daily health care and maintenance of the puppy. This includes all immunizations and examinations recommended after purchase, as well as providing necessary medications and follow up treatments from the veterinarian visits.

If Full AKC with Breeding rights are purchased: At the time of sale, this dog/puppy is considered and being sold with full AKC rights. 618 Frenchie gives no guarantee that disqualifying faults will not arise at a later date which would make this puppy unsuitable for the show ring or for breeding.

Buyer agrees to contact the seller for advice and/or assistance if the above conditions can not be adequately met and/or of no fault of the puppy. Buyer agrees to contact the seller in writing if he/she is unable to keep this dog for ANY reason. Breeder will either accept the dog on a return basis or assist the buyer in finding a suitable alternative home for the dog. This does not imply a financial commitment on the part of the breeder. The buyer agrees that this dog will never be turned over to a pound/shelter/humane society as a means of disposal. Buyer understands they are held responsible for expenses of the return dog, until a suitable home may be found, unless other arrangements have been made in writing and agreed upon by both parties. Owner understands that once the dog is rehomed, ANY rehoming fee will be refunded minus any expenses incurred by the breeder, IE vet care, boarding, training, travel or shipping to new home. _____
